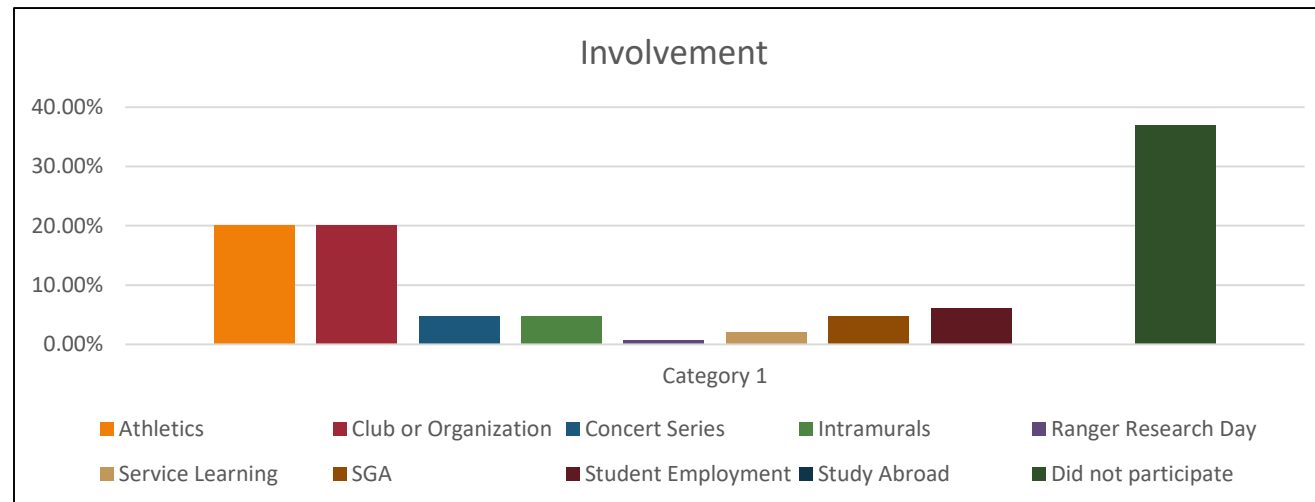
Co-Curricular Learning

The 2021 Co-Curricular Learning survey examined ethical leadership, service, fiscal responsibility, and critical thinking. NWOSU strives to teach students about these four key elements not only in the classroom, but during co-curricular activities as well.

Participants

The survey was made available to all Northwestern Oklahoma State University (NWOSU) students. There were 156 students who completed the survey. Of the participants, 14.74% were freshman, 19.23% were sophomores, 32.05% were juniors, 26.28% were seniors, and 7.69% were

graduate students. The participants consisted of 77.92% female and 20.78% were male. The participants were made up of the following races: American Indian (6.58%), African American (4.61%), Caucasian (75%), Hispanic (12.50%), and Native Hawaiian or Other Pacific Islander (1.32%).

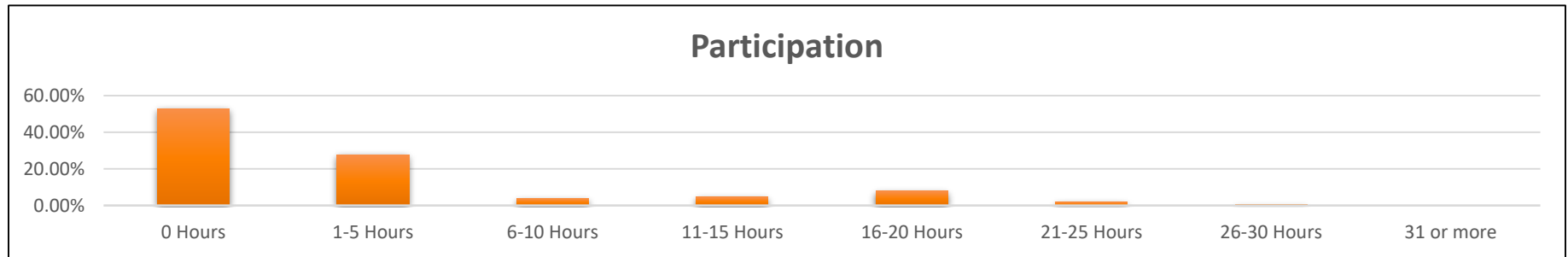


Involvement

The chart to the left reflects what students reported to be the most meaningful co-curricular activity in which they had participated since becoming an NWOSU student.

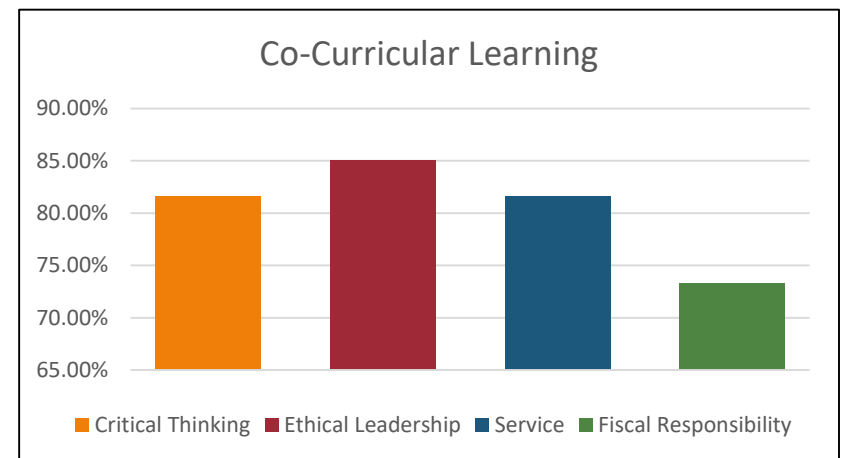
Co-Curricular Participation

Participants were asked how many hours they participated in co-curricular activities. Overall, 52.98% did not participate in co-curricular activities, 27.81% participated in 1-5 hours, 3.97% participated in 6-10 hours, 4.64% participated in 11-15 hours, 7.95% were involved in 16-20 hours, 1.99% participated in 21-25 hours, 0.66% participated in 26-30, and 0% participated in 31 or more. Co-Curricular Learning

The chart to the right shows the percentage of students answering “very likely” or “likely” when rating the likelihood of learning about critical thinking, ethical leadership, service and fiscal responsibility in various co-curricular activities in which they participated.



Examples

Below are a few examples of activities or situations that took place when students were taught more about the following:

- *Critical Thinking*: Planning events, figuring out plays and making quick decisions during games, collaborating with others, and thinking outside the box.
- *Ethical Leadership*: Planning events, representing NWOSU at research day, being a team captain, leading band section, making decisions based on a group, and learning one’s role on a team.
- *Service*: Community service projects, campus cleanup, moving instruments from one place to another, picking up trash at a car show, pumpkin patch set up, serving at a soup supper, Christmas caroling to the elderly.
- *Fiscal Responsibility*: Planning to buy supplies for festival of cultures, fundraising, watching spending while traveling with athletics, dedication to a program from which one receives a scholarship.
